### ***Scholarships (Colleges and Universities)***

- **Carroll College Scholarships**

The following scholarships are available to incoming freshmen at Carroll College:

**Parish Scholarships**

\$500 Scholarships are available to active members of Catholic Parishes throughout the Diocese of Helena. Please note that the application for these scholarships should be returned to the parish not Carroll College.

**Father Sladich Memorial Scholarship**

This scholarship is available to new Carroll students who are currently enrolled with a Native American Tribe. The amount of the scholarship varies from \$1000-\$3000 and is renewable.

**Diversity Scholarships**

A number of \$1000-\$3000 scholarships are awarded each year to outstanding students entering Carroll College with significant ethnic and/or cross-cultural experiences. Priority consideration will be given to students who have a cumulative GPA of at least 3.0.

### **Centennial Leadership Scholarship**

A renewable award with a minimum value of \$1500 will be given to an incoming freshman with financial need who has demonstrated service or leadership in their school, church, and/or community.

**Deadline: Carroll Apps should be received by March 1 (February 15 for the Fr. Sladich Scholarship), with the Scholarship Application also received by March 1**

- **University of Montana Presidential Leadership Scholarships**

A number of full tuition scholarships and partial scholarships are available to the University of Montana. Expected norms are a cumulative GPA of at least 3.5 as well as an ACT of 27/SAT of 1800. To apply, students must complete an application to the Davidson Honors College, by the deadline listed below. Students not awarded a Presidential Leadership Scholarship will automatically be considered for the Montana Resident Entering Student Scholarship. **Deadline: Application must be postmarked by December 31**

- **University of Montana Resident Entering Freshmen Scholarships**

A number of scholarships of varying amounts are available to Montana Residents planning on attending the University of Montana. To qualify, students should have a cumulative GPA of 3.4, and an ACT of 25/SAT of 1700. Please note: if you have completed an application for the Davidson Honors College/UM Presidential Leadership Scholarship you do not need to complete the Resident Entering Freshmen Award application. **Deadline: Application must be postmarked by December 31**

- **Montana State University Presidential Scholarships**

Up to twenty full-tuition, renewable Presidential Scholarships are available for students planning on attending MSU next year. A 3.75 cumulative G.P.A. and a 30 on the ACT/2000 on the SAT are the expected norms for candidates. The selection committee looks for such qualities as academic distinction, service and leadership, imagination, and research/creativity activities. Finalists must complete an interview at MSU from March 4-6.

- Montana State University Resident Freshman Premier Scholarships**  
 A large number of awards, totaling up to \$10,000 (\$2500/year over 4 years) will be awarded to incoming resident freshmen at Montana State University. To apply, students need to complete an application to Montana State, have the SAT/ACT scores officially sent (directly from the testing agency) and complete the Premier Scholarship Application, available at <http://www.montana.edu/admissions/premierscholarship.pdf>. See Mr. McKernan for more information.  
**Deadline: Funds are limited, so apply soon!**
- University of Montana Western Chancellor's Leadership Scholars Award**  
 Full tuition waivers are available to Montana residents planning to attend UM Western. Students must have a minimum GPA of 3.6, and a 26 ACT/1760 SAT, and the application includes a resume, essay, and 2 letters of recommendation. See Mr. McKernan for more information  
**Deadline: All materials (including UM Western App) by February 1**
- Gonzaga University Scholarships**  
 The following scholarships are available for students planning to attend Gonzaga University:

  - Charlotte Y. Martin Scholarship:** \$20000 over four years (\$5000/year) will be awarded to an outstanding graduate of a Montana high school. Minimum G.P.A.: 3.5.
  - Joseph M. Cataldo, S.J. Scholarships:** \$20000 over four years (\$5000/year) will be awarded to outstanding graduates of Catholic high schools. Minimum G.P.A.: 3.5.
  - Dauna Leigh Bauer Scholarship:** \$8000 over four years to outstanding students with demonstrated financial need. FAFSA must be on file by February 1.

- Western Undergraduate Exchange (WUE) Scholarships**  
 Dozens of State Universities throughout the West participate in this program. WUE Scholarships allow out-of-state students to attend certain schools at 150% in-state tuition. This typically means paying just half of that school's out-of-state tuition amount. Each school participates based on its own criteria. Please note that many WUE Scholarships are competitive, and some schools choose to limit WUE Scholarship winners to certain majors. - Boston University Trustee Scholarships**  
 Each year, Boston University awards several 4-year, renewable scholarships to incoming freshmen. Candidates for these awards are nominated by their high schools, and are typically at the top of their class and are active leaders in their schools and communities. See Mr. McKernan or visit [www.bu.edu/admissions/trustee](http://www.bu.edu/admissions/trustee) for more information about receiving a nomination for this award.  
**Deadline: Nominations, essays, and applications must be submitted by December 1**
- Davidson College (NC) John Montgomery Belk Scholarship**  
 Up to five (5) Belk Scholarships are given away each year to students at Davidson College. These scholarships will cover the entire cost of attending Davidson, in addition to two summer stipends to pursue international study and other opportunities. Each high school may nominate one student for this award. See Mr. McKernan for more information.  
**Deadline: Nominations must be received by November 15, applications by December 1**
- Seattle University Sullivan Leadership Award**  
 Nine students will be selected to receive four years full tuition, including room and board. Thirty Six finalists will receive scholarship awards ranging from \$11000-\$18500 per year. Winners will be those who demonstrate leadership, a commitment to social justice, good communication skills, and scholarship (3.5 G.P.A. or above). Candidates will be required to attend the Sullivan Leadership Day competition on Saturday, January 16. Finalists are required to attend the final competition day on Friday, February 26.

### *Scholarships (Independent)*

- Montana Sheriffs and Peace Officers Association Scholarship**  
 Two \$750 scholarships will be awarded to graduating high school seniors who are seeking a career in *local* law enforcement. Recipients will be selected on the basis of need and academic ability as well as career goals. Minimum GPA of 2.5 is required, and preference is given to students enrolling in a Montana college or university. See Mr. McKernan for applications and information.  
**Deadline: Applications must be received by March 31**

- **Plum Creek Community Scholarship**  
 Plum Creek Timber is sponsoring a number of \$1,000 scholarships for students in Western Montana. Applicants must reside in Missoula, Lake, or Mineral County (Ravalli County residents are not eligible). Children or dependents of Plum Creek employees are not eligible, and should contact Plum Creek Human Resources for more information on the Plum Creek Employees Scholarship Program. - **Gates Millennium Scholars Program**  
 1000 scholarships will be awarded to students who are African American, American Indian, Asian Pacific Islander American or Hispanic American. Students must have a minimum 3.3 GPA, have demonstrated leadership through community service, extracurricular or other activities, and meet Federal Pell Grant eligibility. **Deadline: All forms must be submitted by January 11**
- **US Bank Internet Scholarship Program**  
 Forty \$1000 scholarships will be awarded in a random drawing. There is no essay or minimum GPA required. Interested students should go to [www.usbank.com/studentbanking](http://www.usbank.com/studentbanking) and follow the “Planning for College” link to apply.  
**Deadline: March 31**
- **KFC Colonel’s Scholarship Program**  
 Several scholarships are available to graduating seniors planning to attend a public in-state university. A minimum GPA of 2.75 is required. Financial need is a component of this award. Visit [www.kfcscholars.org](http://www.kfcscholars.org) for applications and information.  
**Deadline: Applications are available online from December 1 through February 10**
- **AXA Achievement Scholarships**  
 One winner from each state will be awarded a \$10,000 scholarship. 10 grand prize winners will get an additional \$15,000. Winners are those that demonstrate ambition and drive, determination, respect, and the ability to succeed in college. - **Fireside Catholic Publishing Essay Scholarship**

- **Burger King Scholars Program**  
Hundreds of nonrenewable \$1000 awards will be given to graduating seniors by Burger King. Students must have a 2.5 cumulative GPA, and work at least 10 hours a week for 40 weeks per year (employment at Burger King is not required). Candidates should also demonstrate participation in community service and/or co-curricular activities, and demonstrate financial need. - **Elks National Foundation Legacy Awards**  
250 renewable, \$1,000 scholarships (\$4000 total value) are available to graduating seniors who are the children or grandchildren of Elk members. Candidates must also demonstrate the core values of the Elks National Foundation: Knowledge, Charity, Community, and Integrity and have taken an SAT or ACT by December 31.
