Each year the school publishes a "Family Calling Guide" for all families in Missoula Catholic Schools (both St. Joseph and Loyola Sacred Heart). By signing below, I give permission to publish my information in the "Family Calling Guide". If I do not, I will submit, in writing, a request to not publish my information to the school office.

VI. Parent / Student Handbook Agreement

In consideration of my child (ren) attending Missoula Catholic Schools, I agree that the Administration, Faculty, and Support Staff have the right to expect that all children and parents will comply with the terms, principles, rules and regulations, as outlined in the Parent / Student Handbook. As a condition of attending the Catholic school, each family is responsible for a tuition obligation. All tuition assessments, payments, and assistance are established by the Tuition Office. Failure to communicate or remit tuition may result in student dismissal. A student enrolled in MCS for any part of a semester shall be billed for that entire semester. Refunds for overpayment of tuition shall be made in a timely manner by semester. I acknowledge that if, in the opinion of the School Administration, student or parental behavior, actions, or words interfere with the teaching, learning, mission, environment, or reputation of the Catholic school, the school reserves the right to dismiss the student and/or dissolve its relationship with the family. I acknowledge that attending a Catholic school is a privilege and that it is my responsibility to cooperate with the school for the spiritual development, education and welfare of all students attending the Catholic school. I understand that the Catholic school will make every reasonable effort to educate my child (ren) and accommodate all student spiritual development and environmental needs. I understand that as a parent, I am the primary educator of faith formation for my child (ren). If Catholic, I am expected to actively participate in the life of my parish by attending Mass, contributing financially to its support, and conscientiously developing a sense of Catholic community among my family, my parish, and school. If non-Catholic, I will respect and support the teachings, practices, and beliefs of the Roman Catholic faith and Catholic school program.

VII. Scrip Program

The Scrip Program is currently used as a tuition reduction program. The program generates funding to your Scrip Account by you purchasing gift cards/gift certificates (Scrip) from many stores where you already shop. The Scrip Office purchases these gift cards/gift certificates at a discount from local and national merchants and sells them to you at face value. With over 100 merchants to choose from, you can earn tuition credit (less an administrative fee) towards your next year's tuition. The Scrip Program is no longer mandatory, but we hope families will use Scrip proactively and consistently to directly impact their tuition bill with every possible purchase. The Scrip Office is located next to Loyola Sacred Heart High School in the Foundation Building (300 Edith Street).

VIII. Family Service Hours

In an effort to reduce the operational costs of the schools and increase the fundraising capacity of our Foundation, Missoula Catholic Schools requires twenty (20) hours of parental service each year*. (Cash in lieu of hours = \$15.00 per hour). Twenty Family Service Hours (10 hours dedicated to Fundraising and 10 hours dedicated to school service) per school year of your time is required to make this possible.

Ten (10) hours are dedicated to help in school operations and/or classroom environment. This may include service as a room parent, teacher's aide, or student tutor. It may also include areas such as helping in the lunchroom, organizing open house, or helping with a student activity. Please contact the school secretary, the principal, or your child's teacher for areas that you may be able to be of service to the school.

Ten (10) service hours are dedicated in assisting the LSH Foundation in its fundraising efforts for Missoula Catholic Schools. All money raised by the Foundation is directed to tuition assistance. For a complete list of fundraising events, the LSH Foundation publishes the "Putting the FUN in Fundraising – A Handy Reference Guide to Giving for Families of Missoula Catholic Schools", available from the Foundation Office. (* *Single parent families are required to complete one-half (50%) of this obligation*)
